MEMBERSHIP QUALIFICATION

In order to be eligible for membership in the IPCPR an International retail member must meet **ALL** of the following criteria:

- be a conventional retail tobacconist selling premium cigars, pipes, pipe tobacco and related accessories
- maintain the primary source of business as the retail sale of tobacco and related products,
- operate a retail store in a location with retail zoning,
- be accessible to the general public during normally accepted retail business hours
- have exterior signage with the store name visible to the passing public
- IPCPR membership is valid for a single store only (additional membership applications may be submitted for additional store(s) if desired)

Important Note: Online retailers, mail order-only operations, cigar clubs, and private individuals are not eligible for IPCPR membership.
